Minutes from the April 2nd 2015 Corvette Meeting

President, Rich Allen, called the meeting to order at 7:35 PM. Rich mentioned that the speaker system was not working and would need to replace a part at a cost of \$60. He thanked Dave Gatt for donating it but it might be time to get a different system. He described one that can be purchased at Costco for around \$150 with tax and could be used for all our events including our upcoming Convention in July. A Motion was made to purchase a new PA system. The Motion was seconded and approved to purchase a new speaker system. Rich introduced new perspective members Amy and Jack Pera. They actually live in Livermore but have recently joined the Discovery Bay Yacht Club and heard about our club through our President. Rich stated it was good to see Dick Realph at the meeting. He recently had knee replacement surgery and it's doing very well. Rich went on to thank Al and Paula Sauvadon for their run to Leer Vineyards. It was a great event and the location and venue were wonderful. Rich further stated that Steve was absent and Marilyn would be taking the minutes.

Vice President, Mark Zupan, was not present for the meeting. He and Denise are still traveling all over the United States with their RV and having a great time. In his absence, Rich welcomed Vicki and Dave Hunter as official members to the club and stated that their badges would be ready by next meeting. He also mentioned that the Glass Pacs had canceled their Car Show this year.

Treasurer, Brian Enbom, stated that we still have money in the bank and gave his report of expenditures. Secretary, Steve Gilpin, was absent for this meeting.

WSSC Representative, Lee Brant reported that the Track event that was scheduled for Convention has been canceled. There is a crack in the track and it could not be fixed in time for convention. He further reported that Sunday, April 26th there was a Legends on Display car show in Blackhawk. He will lead the group if anyone is interested and the caravan would leave at 9:00. The cost is \$10 for senior citizens. There is a museum there also and they are presently displaying old jukeboxes and other items of interest. Rich asked Steve Buckman to organize a golf group for our members who want to play golf at convention.

Events, Al Sauvadon, introduced Laura who spoke about the Levi Stadium run on April 19th. She stated that you can only take in water with you and that no food is allowed in the stadium or museum. We will leave around 8:15 from Chase parking lot. Al introduced Giancarlo who spoke about the Mystery Run he has organized. There is a small group going and if anyone is interested please let him know. Al introduced David Vercoe who talked about having a run to Unwind in Discovery Bay. He stated that they can do an outdoor Bar B Q for us and perhaps we could make it a fundraiser. He will talk to them about having it perhaps in May. Al stated that the Hospitality Committee had met and had several good ideas. He called upon Marilyn to elaborate. She stated that the theme would be "Spirit of America/ Celebrating 60 years of America's Sports car". Color would be red, white, and blue and would be especially appropriate because of the convention being held the week of the 4th of July. We would be using the nice charts that Lee Brant made for our last car show depicting the 60 years of Corvettes and featuring the 7 generations of them. Marilyn asked for a motion to approve a budget of \$500 for our hospitality suite at convention this year. A motion

was made, seconded and approved for a budget of \$500 for expenses for the hospitality room. Motion passed. Joanne noted that the trip to Old Sacramento might not take place because of the cost. She is working on having a run possibly to the Ride Hotel instead. She will have more information at our May meeting. Paula shared some brochures she picked up from Sacramento that might be interesting for possible runs. Al stated that May 16th was the Abel all GM car show and that all our members were expected to try and attend since they are our sponsors. Lowell mentioned that there was a place in Fairfield who does great alignments. Able recommended them.

Publications, Laura Hardt, asked that everyone please submit their articles to her for the newsletter by the 15th of the month. If you wish to submit an article that is longer than one page, please let her know in advance so she can allow room for it. Please remember to submit pictures for the newsletter.

Member at Large, Nelson Friesen, reported that the plans for the Inaugural next year are on schedule.

NCM Representative, Dave Gatt, introduced Denise Werkheiser as a perspective member. She just bought a new C7. He further reported that there was a Banquet on May 2nd at Laguna Seca and that registration was \$58. Several of us went last year and had a wonderful time. He also stated that the museum had just made their 10,000 delivery of new Corvettes. A few of our members have gone back to Bowling Green and driven their new cars back. Dave also mentioned that the museum was offering a Lady Garage Party.

Public Relations, Marilyn Allen, said she will be starting to work on a flyer for our club. Joyce Friesen volunteered to help her with it.

Quartermaster, Diana Cernera, stated that she got rid of all the T-shirts that were in storage and that those who wanted shirts for convention to contact her soon.

Sunshine, Mary Hodel, stated that Dick was doing well after his knee surgery and that Marilyn Allen would be having knee replacement surgery next month. Patti brought treats.

Webmaster, Ralph Cernera, had no report.

Old Business, Rich stated that we had officially received our 501C7 Organization status. We have a valid EIN number. This will allow us to get insurance for the Board members as well as for the run leaders. We will need to adjust our By-Laws to reflect our new status.

Rich asked for a Motion to approve last month's minutes and the Treasurer's report. The Motion was made, seconded and approved.
Meeting was adjourned at 8:45 PM

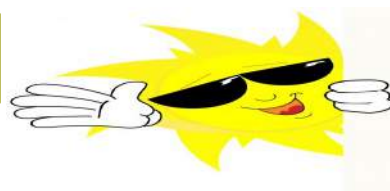

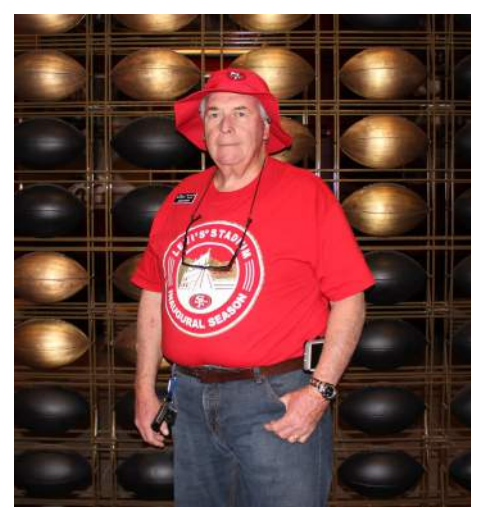
