DBCC GENERAL MEETING MINUTES DATE: 5-5-2022

Call to Order: Time: 7:34pm by Dave Peck. 40 Members present. 3 Guests present

President's Report (Dave Peck): The focus of Dave's report has to do with the WSCC insurance issues which will be brought up under Old Business (below).

Vice President's Report (Shari): Guests' tonight were Rick and Kathleen Craig. New members are Carl and Tammie Guth. Shari is organizing a car show at Serendipity Winery in Brentwood on Sunday, June 5th from 11am to 3pm. Shari is working on Anniversary Certificates and will get current in the next few months.

Secretary's Report (Bill Montgomery): Please sign the sign-in sheet. Call for approval of last meeting minutes in April (see April newsletter). Motion to approve made by Bob Anderson and seconded by Ed O'Brien. Motion approved and carried. Briefly discussed upcoming revisions to Bylaws. This effort has been put on hold for another month due to the need to vote and resolve the WSCC insurance issues.

Treasurer's Report (Brian Enbom): Brian reported the bank account balance.

WSCC Report (Tim Denham): No specific report other than resolving the WSCC Insurance issue.

Webmaster Report (Ralph Cernera): Ralph stated that the Newsletter has been posted to the club website.

Publication's Report (Laura Hardt): Requested photos from events and even from your personal vacations.

Quarter Master Report (Nancy O'Brien): Nancy taking orders for the club t-shirts. Can be ordered in Ash or White. Needs a minimum of 36 shirts to order from our vendor. Nancy has several shirts for sale, first come first serve.

Board Member at Large Report (Ed O'Brien): Present but no report

Events Report (Karen Murphy): Mystery Run on Sunday, May 15th. Please sign up by the 10th. Cars and Coffee on May 21st, 8-10am. Serendipity Winery car show on Sunday, June 5th, 11-3pm. No July runs currently planned. Blackhawk Museum run planned for August. No date set yet. September runs not yet planned, but possibly Jamestown. October is open at this time. November run is to Morris Nursery in Riverbank. Date and time to be set. Suggestion for runs were Highwater Brewery in Lodi and Griff's in Copperopolis in June. Karen needs leaders for both runs.

Public Relations Report (Jenifer Montgomery): Grapevine ad updated to show Shari's phone number. Jenifer contacted the Delta Sun Times. An ad was submitted to the editor so it should show up next month. Cost is free for the listing. Jenifer also contacted the Brentwood Press for advertising. An ad was submitted to The Press and it was published in the issue coming out today (5/5/22). Cost is free for the listing.

Sunshine Report (Connie Miller): Snacks at May meeting: Karen Murphy and Cheryl Fleb'ut provided great Cinco de Mayo desserts. Next meeting (June) snacks by: Debbie Gatts and Neva Burdick. Jenifer is doing better and started her radiation treatments. Amy is doing better. Paul doing better. Upcoming birthdays were announced.

NCM Ambassador Report (Dave Gatt): Corvette Racing came in 4th at Laguna Seca. Several Club members have been invited to the upcoming Z06 reveal.

Old Business: Discussed the DBCC insurance issues that we are having with WSCC. It was decided that the WSCC insurance was no longer suiting the needs of the club. Research during the past month has shown that a policy can be acquired from Hagerty for \$769, and that this is not only cheaper than the WSCC insurance, but also more manageable from a paperwork standpoint, and doesn't require a per event cost. Members discussed the positives and negatives of the change and wanted to be sure that Hagerty was a reputable company (A rated), and that the liability and O&D insurance was adequate. After a period of discussion, Rich Allen made a motion, that was seconded by Ed O'Brien, to approve the BOD proposal to procure D&O insurance, and Liability Insurance, from Hagerty Insurance Company (underwritten by Travelers) in the amount of \$769/year, (which would replace the insurance currently offered by the WSCC), under the condition that the DBCC BOD continues to pursue and review other potential policies that may be an improvement on the subject policy, and to then report back to the membership that Hagerty continues to be an adequate form of insurance for our needs. The motion discussed, and then a vote was made to approve the motion. The 40 present voting and eligible members at the meeting (representing a quorum) overwhelmingly approved the motion with no descending votes. The motion was passed and carried, and the BOD can move forward in the procurement of this insurance immediately.

New Business: Lowell brought up the question as to whether there is still a club shirt. BOD to discuss at next BOD meeting.

Close: 50/50 Raffle: Won by Debbie Gatt (\$60.00). Motion to close by Dave Gatts, 2nd by Ed O'Brien. Motion approved and carried.

Meeting adjourned by Dave Peck @ 8:31pm
