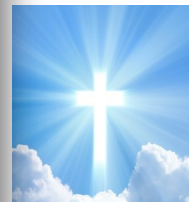

DBCC GENERAL MEETING MINUTES/ORDER OF BUSINESS DATE: 10-3-2024

Call to Order: – Time: 7:41 pm by Shari Peck at the Discovery Bay Yacht Club, Bilge Room

33 Members present. 0 Guests present.

President's Report (Shari Peck): *Shari started the meeting with the Pledge of Allegiance.

Vice President's Report (Tim Denham) *Discussed the Caravan and how much fun it was. Mentioned the article in the current Newsletter.

Treasurer's Report (Lisa Williams): *Lisa reported the amount of money in the account – (See BOD minutes for amount). *Lisa reported income at \$0 for last month. Expenses were \$656.16 for Insurance, Pera's for the 35th Anniversary expenses and Flowers. (\$418 was to Travelers Insurance)

Secretary's Report (Bill Montgomery): *There was a call for approval of the prior month's meeting minutes from the August (8/13) meeting (see August Newsletter) and the September meeting minutes (see September Newsletter). Motion to approve both made by Brian Enbom and seconded by Diana Cernera. Everyone was in favor. No one opposed. Motion approved and carried. Both minutes passed as published. *Be sure to sign the sign-up sheet. *Mentioned that the updated Standing Rules dated 10/11/24 were approved by the BOD earlier this evening and will be posted on the Members Only website section in the next few days. *There was some discussion that the BOD is considering replacing the worn out brick at the NCM in Bowling Green Kentucky. Costs have not yet been determined. Still waiting for more information from the NCM. *Discussion about the Caravan continues, and it was mentioned that the next newsletter will have more photos of the Caravan and perhaps another article to add to the one Bill wrote for this month's Newsletter. This month's Newsletter was very nice and dedicated to some folks that we lost the past few months.

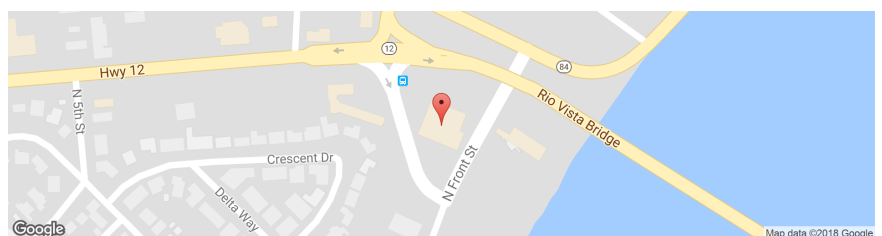

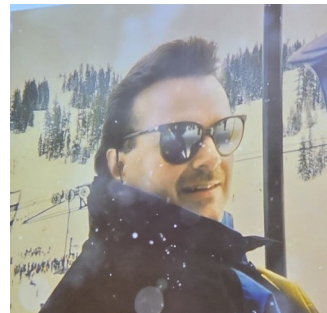

was going to call your name.*

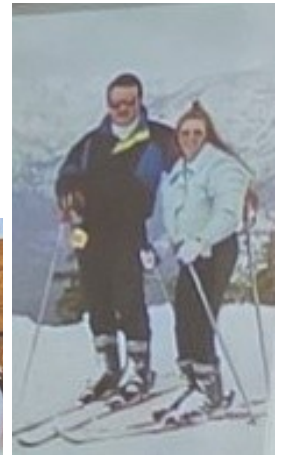

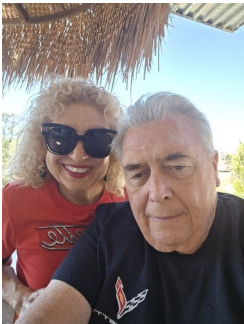
