DBCC GENERAL MEETING MINUTES/ORDER OF BUSINESS DATE: 1-2-2025

Call to Order: – Time: 7:34 pm by Tim Denham at the Discovery Bay Yacht Club, Bilge Room 23 Members present. 0 Guests present.

President's Report (Shari Peck): *Tim started the meeting with the Pledge of Allegiance

Vice President's Report (Tim Denham) *Mark and Cecilia Dioso were voted into the Club unanimously. They are now official members of the Club. Dues is now \$110 to renew after tonight.

Treasurer's Report (Lisa Williams): *Lisa reported the amount of money in the account – (See BOD minutes for amount). Lisa reported income at \$1,580 for last month. Expenses were \$1,937.40. Lisa reported that our storage unit cost (increase of \$5/mo), and the cost of the PO Box (amount of increased not reported) are going up this year.

Secretary's Report (Bill Montgomery): *There was a call for approval of the prior month's meeting minutes from the November (11/7) meeting (see November/December Newsletter). Motion to approve both made by Roy Brett and seconded by Rich Brunetto. Everyone was in favor. No one opposed. Motion approved and carried. Be sure to sign the sign-up sheet. Regarding the replacement of the NCM Club brick that Tim and Bill are working on, Lowell suggested having a new brick made locally (like at Laser Impressions in Sunnyvale), and then ship it back to the NCM for installation. We will investigate that suggestion. We are waiting to hear from the NCM in February or March to see if they replaced their brick vendor.






